Killing those who dared to defame Islam and the Messenger in Bangladesh

-Sentencing innocent Muslims to death in the name of Justice-

The Messenger of Allah (said:

"لزوال الدنيا أهون على الله من قتل مؤمن بغير حق." 1

"The destruction of the entire world is lighter in the sight of Allah than the unjust killing of a believer."

For the crimes of denigrating and slandering the rulings of Islam, on 15th November 2014 CE (Muharram 1436 AH), mujahideen of Al Qa'eda in the Subcontinent executed the known Islamophobe Shafiul Islam Lilon in Rajshahi, Bangladesh. On 12th May 2015 CE (Rajab 1436 AH), Ananta Bijoy; another Islamophobe guilty of defaming and insulting the Messenger of Allah (**), received his due in the hands of the mujahideen of Al Qa'eda in the Subcontinent. Alhamdulillah, success is only from Allah. Al Qa'eda in the Subcontinent subsequently released statements claiming responsibility for both these raids.

These men were not killed for merely being atheists or Islamophobic in their personal lives. Rather, they were open enemies of society and humanity. They were fixated on denigrating and slandering Islam and Muslims. They insulted and defamed the Messenger of Allah (**); who is dearer to Muslims than their own lives, in extremely vile and evil manner. These transgressions were equivalent to an open declaration of war against Allah, His Messenger (**), and the Muslim nation in general. According to the Shariah of Allah, the Lord of the worlds, executing these two men was an obligation upon the Muslims. But being obedient agents of the Hindutva menace, the *taghut* government of Bangladesh did nothing to bring these men to justice. Instead the government provided security to these criminals. Not only that, the government jailed and killed the Muslims who demanded punishment for these men. By the grace of Allah, the Most High, the mujahideen of Al Qa'eda in the Subcontinent were able to give these vermin their due. The mujahideen carried out the duty enjoined by the Shariah and thus cooled the hearts and eyes of hundreds of millions of Muslims. All praise is only for Allah.

Following these blessed raids, so called "trials" were undertaken by the manmade tyrannical judicial system of Bangladesh. In order to hide their inability and failure, they convicted people who had no connection whatsoever with these raids. Recently, the inept courts of manmade laws sentenced three persons to death for the killing of Lilon, while four where given the same sentence for the killing of Ananta Bijoy.

We declare clearly and openly; it was the honourable mujahideen of Al Qa'eda in the Subcontinent who killed these two criminals. The seven persons sentenced to death by the courts of Bangladesh, had nothing to do with these raids. Neither did they have any connection with the mujahideen of Al Qa'eda in the Subcontinent. To sentence these seven innocent persons to death for the killings of Lilon and Ananta Bijoy is wrong and entirely unjust. Not only according to

Islamic Shariah, but also from the point of view of pure rationality and even manmade laws. Indeed, such ineptitude is truly shameful for a state and its justice system.

Such farcical investigations, trials and verdicts illustrate the inability and inadequacy of manmade laws in particular, and the *taghuti* system in general. This is a system, which protects defamers and slanderers against Islam and the Messenger of Allah (a), instead of punishing them. This is a system, which sentences innocent people who had nothing to do with the matter concerned, to death in the name of justice. This manmade system can neither define crime, nor can it ensure justice and fairness. Yet for many decades people are suffering under this unjust, inept state and judicial system. The only way to be free from this slavery is to throw away manmade ideologies and systems, and to follow the Shariah of Allah.

To all those connected with these farcical trials and verdicts, we say: Repent and return from such oppression and injustice. Such abuse of judicial power is truly shameful. Remember, a day is coming when you too will have to face the judgment of the Ultimate Judge. A day when people will not be able to free themselves even by ransoming their own children or all the riches of the earth. Therefore, acquit these seven innocent persons whom you have wrongfully convicted and sentenced to death. And return to the blessed shade of Islam and the Shariah for the good of your worldly life and the hereafter.

May Allah shower His blessings upon the Muslim Ummah. May He establish Islam on this land. So that the oppressed will be aided, the oppressor will be prevented and the people will receive true justice and security, Ameen.
