## TO: All EDGE&TA Members

### Larry Voris, President-Director at Large

Spring is here and we should be thankful. It has been a bad winter in the North half of the USA this year and South wasn't any to warm. By now the winter projects should be getting close to the point to where paint is the only thing needed for completion.

Several new questions have been submitted to the insurance company for answers. Everyone has a different angle of thought.

1. Members are afforded liability insurance coverage anywhere they go provided they follow the EDGETA Safety requirements

2. To have event coverage, the event must be pre-reported 30 days and not less than 10 days prior to the event. It is up to a designated person in the branch to handle the reporting of events on the web page. If a sponsored event is not reported, then there is no insurance coverage for the event in case of an incident

Members would have individual coverage, but if someone would bring a lawsuit against the branch they would not have coverage. So to all members, ask the officers if the event has been reported.

Show season is right around the corner. I hope everyone that is planning to attend the National show in Hutchinson, KS this summer should have made your reservations. If not, call immediately for reservations. I understand there will be a couple of other events taking place at the same fair grounds besides our show.

There are a lot of things in the Hutchinson area. So come a day early and stay an extra day to see all the sites.

Everybody from the Midwest that is planning on driving, be sure and hook the trailer behind and bring something to exhibit. Branch 55 has been planning for over a year for this show. Lets all help them make this the biggest show ever and we have had a lot of good shows.

We are not an insurance company, even though we have an excellent coverage for our members. We want to be known for helping people from all walks of life, research and give information to help them resurrect and restore antique equipment. Always remember the purpose of our organization is to promote the collection, restoration, preservation, exhibition of gasoline and oil engines, gas & steam tractors, power driven machinery, other equipment of historical value. Further to promote fellowship of those with common interest in the hobby. Other equipment of historical value covers a large area. As I may have mentioned before, if you have 1 historical item, you have a historical piece, but if you have 2

pieces, you have the starting of a collection. We seem to think that our club only has tractors and engines. Many of our members may not own a tractor or engine. They may collect wrenches, broom maker, spark plugs, jacks & wooden corn equipment. We see rope makers and broom makers which are both of historical value. It takes everything to make a good show.

Demonstrations are good at shows. Some shows you see equipment mounted on tractors and some you don't. You get a tractor all restored and painted; it looks great, probably better than it did when it was new. But to a young person or a spectator that has been raised in the city, they say what did it do? This is where you explain to them how it works and what it did. Some people don't have a clue what our ancestors went through just to survive the cold winters, hot summers and floods and drought. Showing and exhibiting equipment is hard work if you stay with your exhibit and explain what it did and what makes it work. I don't think I have ever seen anyone sharpen a sickle at a show.

You can have the oldest engine or tractor at the show all painted and spit shined, and beside it a tractor or engine ½ the age or maybe newer with no paint, and sometimes it will draw more attention. The people will say, boy that is old. How old is it? Where did you find it? Where do you find parts to make it run? This is where you need to be there with a story. They will eat this up. It sounds like I don't like paint. Some of my stuff doesn't have paint. But I admire the equipment that has paint and the owner that can keep it looking like new. I have a 5 HP Witte belted to a No. 4 Bowsher mill. Neither has paint. I have asked several spectators if I should paint them. All say no. With the engine chugging away and steam coming out of the water hopper, grease and oil down in the crank pit and dust coming from the mill, it is a working exhibit and it would be nearly impossible to keep it clean after a 3-day show and operating for 8 hours each day.

Then there are the people that unload the equipment and kind of get everything ready to exhibit, then leave and head for the flea market looking for parts or another project. Are you one of them? I'm not going to comment on myself.

Probably the worst thing is helping put on a show. Someone has to do it. You have to have someone at the gates, parking exhibitors and cars, dust control, bathrooms, registration, announce parades, and the list go on & on. If every member of the hosting show would give 1 hour to a 3 day show, most all the jobs would get done and everyone could exhibit there equipment and have fun. You look around and think well that person hasn't done anything today. Well, maybe he worked all summer on the grounds, he arranged for the port-a-pots, wrote the newsletter, ordered the trophies for the tractor pull and picked them up, put up all the signs around

the grounds, picked up trash every night after everyone else went home. Yes, and maybe he really hasn't done anything. Maybe he hasn't been asked in a nice way. We have to do all these jobs and smile like we are having fun because next week we are going to another clubs show and exhibit our equipment and watch and see how they put on there show. I'm sure you all have heard, no paper in the restrooms, the port-a-pot is full, how come the parade is late, and the program says the saw mill was supposed to operate at 1:00 PM. I drove 100 mile to bring my dad who is in a wheelchair and he can only be in the chair 30 minutes at a time and the saw mill is not sawing lumber. Then a young couple with 2 kids come in and walks through for a couple of hours and say, "we want our money back." They say they walked through the engine section and nothing was running. No action going on.

Especially don't get stressed out at another co-worker just because you haven't had a good day. You aren't wearing there shoes and don't know what they have been going through or what they have been doing. Your problems are probably far less than theirs. Communications among the workers is the best way to keep piece in the family. Sometimes things happen beyond our control and things changes and you don't have time to communicate. So don't get stressed out and blow your cork. If you don't know the answer or what to do, ask and be patient. Besides these are all volunteer jobs. If you need help with a task and no one is available, sit down and look around and see what is going on. Most of the men are with their engines or tractors. Then you observe several ladies visiting trying not to be bored and bingo. They can't do the physical work but can do the paper work of registering exhibitors, tractor pulls, membership and many other jobs. And they do a good job too. But, most important is to thank them for a job well done when the show is over.

It takes everyone to make a show successful. First, it takes spectators coming through the gate. Second, we have to entertain them every minute they are here, because we want them to come back next year.

I'm off my soap box now. Have a good year. Hope to see you at a show soon.

**SUPPORT & SAFETY-Dorene Yearian, VP/NC Director**  
For some of us in the middle and the east side of the country, we are getting ready for the coming tractor shows. You on the west side of the country have already started. I ask of you two things – *support and safety*.

**Support** – remember there are many, many little shows around you that need your support and help. Make a list of the shows around you and start calling your friends to get them to attend with you, and then go and advertise your own show. Tell them how great your show is. Call or go early and see if they need help in setting up. You never know you might make the acquaintance of someone that knows someone that has that part you are looking for and have yet to find. Make new friends.

Try and attend your regional show. In the NC area the show is in Almelund, MN, August 10 & 12. I have attended this show before. It has a big show area, big swap meet area, playground for children, entertainment, buildings with

different demonstrations, tractor parade, and a tractor pull. You will have a fun time.

I want to see every one of you at the National Show this year as it is in the middle of the country – Hutchinson, KS, July 14 & 15.

**Safety** – I know we keep harping on safety. Every one of our magazines always has some articles on safety. An article from Successful Farming magazine writes that law officials are cracking down on trailering violations even with the tie-downs. Some states require a tie down on four corners of your equipment and in some only if the equipment weighs over 10,000 do you need a tie down on each of the four corners. Remember Federal regulations require that individual tie-down chains or straps have a working load capacity equal to one half the entire weight of the equipment you are hauling. Remember you can receive a violation if your straps or chains are damaged. In almost all states a trailer carrying more than 10,000 pounds requires brakes on all axles. The contents of the trailer must not exceed the manufacturer's maximum weight limits. Most of all remember that the pulling vehicle must be adequate for the trailer and its load. You have to stop safely. Remember every state is different and not knowing its laws is no excuse.

Please make sure each and every one of you is safe this year. Remember every member has insurance coverage to all shows whether it's an EDGE&TA sponsored show or others as long as you follow our safety requirements.

**Insurance Update, March 2007**

Our insurance year is from April 15 to April 15. For those of you that request Additional Insured certificates/Proof of Insurance at this time they sometimes get delayed until after April 15<sup>th</sup>. This gets to be a problem especially if your event occurs right after April 15<sup>th</sup>, and you request the certificate before April 15<sup>th</sup>. Our insurance agent cannot issue the certificates until the new policy is in place. Please be patient, and we will try to accommodate your needs as best we can.

Also remember that your national dues and insurance premium this year is \$9/member, not \$10 as it was last year. Your first payment was due on March 15<sup>th</sup>, so I am sure you have all sent your payment in by time you get this newsletter.

Another reminder, the insurance agent will no longer be sending out insurance certificates in April/May to each branch as they have done in the past. In years past each branch could show this form to those asking for proof that your branch had insurance. This year, if someone needs proof that your branch has insurance; go to the EDGETA web site and under insurance info click on the form to submit a request for proof of insurance. It will be sent to the person requesting the proof of insurance, not your branch.

And another reminder, the events that are sponsored by your branch must be reported to the insurance agent between 30 days and no later than 10 days prior to the event. If you are

co-sponsoring or helping with the organization of an event, you need to report it to have insurance coverage. Non-sponsored events do not need to be reported; those EDGETA branch members that attend do have EDGETA insurance coverage, but must follow EDGETA safety requirements.

We continually get questions on insurance coverage, and do our best to get back to you as soon as we know the answer. If we are not sure of the answer we pass the question on the insurance carrier, and it takes time to get an answer back. We will be updating our Q&A shortly with some recent questions that we have been asked. This is a changing world, so for the latest information, keep checking back to our Q&A section under insurance on our web page, [www.edgeta.org](http://www.edgeta.org).

On a non insurance issue I attended the Larry Weber antique tractor auction the first part of March in Yuma, AZ. I can report to you that your tractor investments are doing well, especially if it a rare tractor. You may want to pass this on to your wife, tell her that your tractor investments are appreciating and doing well. She may give you approval to buy more tractors, especially that rare one that you have always wanted!!

Don't let your guard down on safety.

It is good idea to also check the Q & A section of the Safety Requirements. Many of the branches have the same questions and many of these questions have already been answered in this section of our web page.

We, the officers and directors of EDGE&TA, are always working to improve the safety record of our organization and keep the membership informed of any changes that might affect the safety at our sponsored events. If any branch has a question about safety please let one of us know about it and

we will get you an answer as quickly as we can. The only "dumb question" is the one that isn't asked.

Recently overheard at a non EDGE&TA event were two of the Sponsoring Organization's officials discussing the conduct of a group of tractor and engine exhibitor's (EDGE&TA Branch). One was saying to the other, "Those tractor and engine folks always seem to be doing their thing in the safest way possible. If we could just get the rest of the exhibitors to follow their example we would not have so many gray hairs." They went on to say that was one of the reasons they always invited the group to attend their function and because they always seemed to be having a good time while at the event.

**WARNING: to all EDGE&TA members.** Be careful how you observe the safety regulations, you never know who might be watching!

I met with the SC Regional show hosts, Branches 116 & 120 in Broken Arrow, OK a couple of weeks ago they are working hard to insure the show will be a success in September. There are a lot of things see and do in the Tulsa area, so when you are making your plans to attend the SC Regional Show include a couple of extra days to take in the sights.

I would like to share a little bit of history with everyone. March 10<sup>th</sup> marks a date on the calendar in honor of two people that had a great influence on the art culture here in the coastal area of South Carolina. They were Anna Hyatt Huntington and Archer Milton Huntington.

She was a sculptor. He was a scholar of Spanish culture and a railroad baron heir. They were both born on March 10<sup>th</sup> and later married on the same date. They bought their 6,635 acre estate in Georgetown County in 1930. The acreage consisted of marshland, forest and beach. They built a 30 room "castle" as a winter sanctuary to help ease Anna Huntington's tuberculosis. They seemed to be very low key in their lifestyle. The home's lack of guest rooms lend to that fact. There were rooms for cooks, housekeepers and servants, along with a library, oyster shucking room and bear pens.

I know you are curious about the bear pens but that was just a part of the different animals there on the estate. There

were also monkeys and peafowl that Anna used as subjects for sculpture. Many of these sculptures can be seen in the gardens at Brookgreen Gardens.

I stated earlier that Archer Huntington was a scholar of Spanish culture. The home named Atalaya was modeled in the style of the Moorish architecture of the Spanish Mediterranean coast. The home was used mainly for winter retreats and inspiration for Anna's art. I am sure they spent time with local friends on occasion. I am only guessing here, but I think they used the time just to be together.

The Huntington's spent their last winter at Atalaya in 1947. Most of the homes furnishings were moved to New York City after Archer's death in 1955. The estate tract was leased to the state of South Carolina in 1960 for a park. The park called Huntington State Park is located across the highway from Brookgreen Gardens.

I remember going to both of these places as a child and later in high school and then as a young adulthood, but until I read a recent newspaper article I had never really thought about the people that lived at the estate. After reading the article I began to think about the private lives they must have shared in South Carolina away from the fast paced world of New York City.

The house is only a shell of the home it once was. The walls are stripped to bare brick and cement floors. You can only imagine what the home must have been like inside. The colorful walls, ornate decorative tile floors, what a beautiful sight. We can only see it now in our minds eye.

What does this have to do with antique power equipment? We have a hobby devoted to preserving the past. Just as important as preserving old homes, old power equipment is also part of our culture. How often do you think about the person or people that may have owned the equipment before you? Do you ever stop to wonder, how did these folks live?

The show season is such a busy time. Hope you get out to see the wonderful historic sights that are also available. Please, make safety your #1 priority. Continue to keep our hobby safe. Safety is contagious. I hope to see you at the shows. Take care.
