# Insurance Update, September 2013, By Dick Tombrink, NW Regional Director

My branch #29 hosted the EDGETA NW Regional and Show this year on August 17-18 at the Huntley Project Threshing Bee. We appreciate all of you who were able to attend and help us make it a success. We sincerely appreciate those of you who brought exhibits and participated in our show. We had the pleasure to present the Hall of Fame plaque to Orrin and Cathy Iseminger from Branch 54. Next year the EDGETA National Show and Meeting will be at Branch 51, in Lewistown, Montana on June 14-15. Come back and enjoy Montana, the big sky country.

We have had a good year from an accident standpoint, with no reported claims. This is a result of everyone paying attention and thinking about safety. We all need to be sure we conduct our Branch shows in a safe manner to eliminate claims and be sure everyone goes home at the end of the day safe and happy. Encourage all your members to continue to think safety before each action at a show.

Normally I devote my space in this newsletter to issues relating to our insurance. Since things have been kind of quiet in the insurance area, I am going to pass on a tip that I have used to repair tire wheel rims that have been corroded either by calcium chloride in tires or just wet conditions. Some of you probably have already done this. Most of the time the damage is limited to the area around the valve stem. Find yourself another like size rim that has the same problem,

corrosion around the valve stem. From one you can find good metal to patch the other one. I use a 3" high speed air cut off tool (like those available from Harbor Freight) to cut out the damaged areas. I then transfer the cutout corroded metal to the sacrificial rim and use the cutout as a pattern to cut out the new replacement piece. Make the new piece a little oversize. Position the new piece to the rim being repaired and use the cut off tool to cut trim the pattern to get about 1/8" or less gap all round. Weld the patch in with a wire feed welder. Then use a right angle grinder to clean up the welds, and finish with a flap wheel on the right angle grinder. You will be able to get a smooth surface that is undetectable as being patched. Then finish off by drilling a new valve stem hole, 5/8", at a convenient point. Remember the valve stem hole does not have to be in the patch. It can be elsewhere around the rim. Hope this will help someone with the problem with corroded tire rims.

Hope everyone has a safe Fall and think safety at all times.

This year has gone by rather quickly--only sixty shopping days til Christmas. We have had our share of disasters, fires, floods, tornados, to name a few. We were saddened to learn that one of our EDGETA members was killed in a freak accident while participating in a Fourth of July parade. Our thoughts and prayers go out to the family. As I prepare for Branch 22's fall show September 28-29, I also am packing for my journey to Las Cruces, NM for the SW Regional Show hosted by Branch 160. It is being held October 2-6. The shows aren't over yet. Many more will occur here in the south. Please take time to be safe. If you have a running engine display, keep at least three feet behind the double rope barrier, exhaust away from the viewing public; pay extra attention to small children. Have fire extinguishers and a First Aid Kit within the area. With tractors, beware of your

surroundings, use chock blocks when parked, or apply the brakes. Make sure it is out of gear. Caution when loading and unloading, if your ramps are steep consider backing your tractor unto your trailer.

It has been a good summer for the branches in the Midwest. We did have a couple of feet of rain in August and some cool weather. This slowed down the growing season and is taking a toll on the crops. Some areas of the country are still burning, some have blown away and some have washed away. Is someone trying to tell us something?

It seems that we are having trouble with rides meaning equipment that keeps us from having to do a lot of walking at a show. We can have them, but our EDGETA insurance company no longer covers these vehicles for us. (Golf carts, 4-wheelers, ATV's, Totegoats, gators, motor bikes etc.). This puts the burden of insuring these vehicles back on us. You need to go to your personal insurance agent and see if these vehicles can be put on your homeowners or vehicle insurance policy. Nothing is free anymore.

One way we can do this is have the owner show their insurance card for the "ride vehicle" at the gate when they go to a show. This information needs to be visible so the safety people will know that the vehicle has insurance. If we observe a vehicle without the proper papers, the driver should be escorted back to their trailer, and it should be loaded.

And, "No, it's not going to get any better." Now, if you want to ride, you have to pay.

As we have said before, our insurance covers us if we should have an incident with a spectator. Now, what you should think about is what if you should have an incident incident with another member. Do you have coverage to cover you if this should happen?
