Insurance Update, December 2013, By Dick Tombrink, NW Regional Director

There are several insurance related items that are changing. I want to bring those to your attention. Several FAQ's on the website are being changed or deleted. At this time some of the changes have not been made on the website, but they should be done shortly. The changes are listed below.

1. To be deleted, EDGETA website, FAQ #26, which asks, **We are using an organization called "XYZ Association" for our tractor pull. They have an insurance policy, but are not members of the National EDGE&TA club. Do we need to fax a copy of their policy to you before the show and do their members under their insurance have to still join our club before they can pull?**

The reason it is being deleted is our insurance covers tractor pulls for antique tractors as spelled out in our website tractor pull safety section. It is no longer permissible for branches to allow other organizations to have tractor pulls in conjunction with an EDGETA tractor pull or show. These other organizations do not follow the EDGETA safety guidelines, and are probably modified and "souped up" tractors, which are not allowed under our guidelines. If there was an incident involving the other organization, our insurance would be brought into the legal suit just because it was our show.

2. To be changed, EDGETA FAQ # 28, which states, **Does EDGETA insurance cover a member while riding in his golf cart?**

The new answer is **No, our insurance does not cover golf carts, ATV's, 4 wheelers, Tote Goats, scooters, or like vehicles. Members are encouraged to contact their auto or homeowners insurance agent and obtain personal insurance to cover these vehicles.**

The reason is our insurance policy specifically excludes any mobile equipment that can be licensed for road use. Branch members that operate these vehicles at an EDGETA show need to see their insurance agent and get coverage before bringing them to the show.

3. In the website safety section, page 1, the word sponsored has been deleted from this sentence,

SAFETY MANDATORY REQUIREMENTS FOR ALL EDGE&TA EVENTS

The reason "sponsored" was deleted is that it was a carryover from several years ago when we had to report to our insurance carrier our "sponsored" or "sanctioned" events. We are no longer required to report our events to our insurance carrier. The words do not apply anymore, and are confusing.

4. We are also working on providing more guidance on the use of people movers and barrel rides at non EDGETA events. The wording is not yet finalized, but should be shortly. I will cover that in the next newsletter. If you have a question before that comes out, send me an email with your question, and I will get you an answer.

As I write this, it is about 5 days before Christmas. Our weather has been cold and snowy. We had about 6" of snow, and recently 4 nights where it was between -23 and -29 below. We had a warm spell and most of the snow melted or got blown away. About two days ago, we received 4" of snow, and they predict another 4-6" tomorrow. Guess I better get my tractor chained up to plow snow.

Hope everyone had a Merry Christmas, and a Happy New Year. Keep safety number one in whatever you do.

In the Mid Central part of the USA, fall hasn't been too good to us. We have had 13 inches of snow and the temperature has been down to -0 F already. I realize that what all the northern states get is a lot worse, but this is bad for us. This has put a hold on some of my projects for the season.

A couple of years ago, I come across an "English Bros Steam Stationary Engine" that was made to run off a stationary boiler. It appears to be about a 25 hp engine. It was in a basket so to speak; the man had taken it apart and boxed all the parts up and let it set. He said, "There it is; see if you can make it run." I got it home and had to use a loader to move it around in my carport. I sorted out all the parts and didn't have a clue what some of them were. I'm a tractor man and I didn't find any spark plugs anywhere in the mess of parts. I cleaned everything and had to make a new slide rod and a few other parts had to be repaired. I started back together with it and one of the steam guys asked me if I had it in "time." I looked at him and said, "It doesn't have spark plugs; does it need to be timed?" He gave me a book to read. I read it and looked at the pictures and it was all Greek to me. So after I got the slide valve together, I sat down and started turning the wheels and adjusted it to where I thought it would work. I took it to the OSEA show grounds and bolted it down the day before I was to have surgery. At the show 2 weeks later, they plumbed the engine into the system. They fired the big boiler and went around and opened the valve a little and gave the wheel a push and it started puffing. I was there a couple of days later and got to sit down and play with it. And heaven forbid--it sounded like a John Deere. At least on the stationary engine I can play with it, turn the valve off and go drive a tractor.

What little history I can find on the engine, it was used in Arkansas at a saw mill pulling an edger or planer. The man I got it from came by and watched for a while and said he didn't think he would ever hear and see it run. I asked him if I should paint it and he said, "No."

I think there is a color code for steam lines and it would be a good idea to paint the lines in your steam buildings if you haven't already done this. That's all for now; see you later. All you folks in CA, TX and FL have a fun and safe winter show season.

I hope that all of you have enjoyed a good holiday season. For East Texas, we've had some unusually cold temperature, but it has been a nice change for me. In an effort to assist you. I'm going to devote my article to answering many questions that I've been receiving both by phone and e-mail from branches regarding the new year and all the issues involved

1. The buttons for 2014 and the new stickers that go on the membership cards will be mailed the last week of January or first week of February. The number sent is based on the membership number that your branch had at the end of the 2013 calendar year.

2. Dues for the new year should be sent to me by March 15. That gives me time to get them processed and deposited so that the members are covered by April 15 when the new year begins. Dues are \$12 per person.

3. The new membership year begins April 15, 2014. The new stickers that will be mailed to you do not become effective until that date. Be sure to place them below or above the current sticker if you attach them to membership cards prior to that date.

4. No one should receive an EDGETA membership card and sticker except those whose names you send to me as members of your branch. Individuals may not be a member unless they are carried on a branch roster as a member of a designated branch. You may not issue a card to someone who visits your show because they want to pull unless you add them to your roster and send their membership dues within 30 days of that date. I have had a number of calls from individuals who stated that they had been made members but were not on a Branch Roster. They wanted to know how to handle getting their membership renewed individually.

5. Forms are available on our website for submitting your membership. You may use those or another spreadsheet if you like. We need name, address and phone number for each member you list.

6. Officers and Directors must be updated on our website at the beginning of each year, even if

they stay the same as the previous year. Otherwise, they are not covered by D&O Insurance. Go to the edgeta.com website, scroll down to "Update Officers" and enter your officers. Be sure to click Submit. The same process is used for updating Directors.

I hope these items will address some of your questions. If you have others, I'll be glad to assist you.
