## From George Christmas, President and SE Regional Director

I would like to thank Joe Mangham and the members of Branch 212 for hosting the Southeast Regional show this year. I can't say enough about the members I met at this show. I really appreciate all the hospitality extended during the show. The show was held September 18-20 in conjunction with Inman Farm Heritage Days show just out of Fayetteville, Ga. This was the 19<sup>th</sup> year for this show. The members of Branch 212 had their tractors set up in a designated area. The engines, of course, were setup with other exhibitors, but the branch members had their engines roped off. There was a short tractor drive the afternoon of the 18<sup>th</sup>. The drive began with a safety meeting. Every tractor was equipped with a fire extinguisher and a slow moving vehicle sign. Ed Bottoms is the safety director for the branch but everyone took an active role in monitoring safety and making sure everything and everyone was safe. Each day, the members met for a safety meeting before the show. It was a great show. There were many different demonstrations during the show. There was threshing, syrup making, blacksmiths, a grist mill and moonshine still. The still was not operating, only for observation. There were lots of exhibits to see. The church service on the grounds on Sunday was at the site where a church stood in 1849. There was an excellent number of spectators all three days. If you happen to be in the area next year during the third weekend of September, you would really enjoy this show.

It is very important when you report new members that you include their name, address and phone number. These are important pieces of information. Please note the information needed on the **BRANCH MEMBERS FORM** or you may use an excel spreadsheet to report your members. It is also required for the insurance coverage to be in effect for each member. You must report new

members within 30 days. You need to keep a copy of any correspondence for your own records. This

would be especially for membership lists. Several branches have been requesting copies of their membership rosters. This takes time to send through the regular mail, so if you need it in a hurry, you may not get it in time. Again, it is very important you retain copies for your own records. It is also required that each branch complete the **BRANCH OFFICERS & DIRECTORS UPDATE FORMS.** These forms serve to help us identify who can be contacted at the branch. It verifies the officers for the D & O insurance. The form is set currently that if there is not a change for a specific position you can fill it in with the word "same," submit it and the form will let the secretary know the correct contacts for your branch.

Remember, any correspondence with the national must include your branch number. When your club applied for membership, your club agreed that it would be known as a Branch of EDGE&TA. That number should be on any documents you send to the national secretary. Your club is Branch #\_\_\_\_ of Early Days Gas Engine and Tractor Association. This information should also be on any fliers or posters advertising your branches events. Please make sure you are making your club known as such.

Please review the safety section with your branches. The safety requirements are not optional. You can't use the ones you like or agree with and ignore the rest. The safety requirements were put together by members of the organization with experience in operating tractors, engines and the other equipment. These requirements are not difficult to follow. These were put into place to protect the membership. If you are not following them, you could be putting the other members of the organization at risk. A club or organization is a group of people with the same goal or vision. They look out for each other. Please keep that in mind as you are showing off your antique farm machinery.

One of the questions we get often is concerning membership numbers. Many of our branches have a small number of members. They can no longer sustain the minimum number of 20

members to continue as a branch. We have discussed lowering that minimum number to help with that issue. The change in the minimum number requires a bylaw change by vote of the membership body. If you have thoughts on this, please let us know. Contact your regional director or any of the directors. We would need to bring this item to vote for the 2016 National Meeting.

I encourage all members to visit the website. We are continuing to work to keep it up to date and very user friendly. This is the fastest and most economical way to relay information to as many members as possible. The newsletters are mailed to each Branch President and Safety Officer but the newsletters are posted and archived on the website for access anytime. As you visit the website and have suggestions, please let us know. We may be able to use your suggestions to improve the website for all members. All of the regional shows are posted on the website for next year. The National Show for 2016 will be hosted by Branch 52 in Wasilla, Alaska. I hope everyone is making plans to attend. It is beautiful country up there. It will be a super back drop for an antique farm machinery show.

It is the fall season so there are a lot of festivals, carnivals, fairs and shows going on for the next couple of months. Please take the time to make our hobby safe for everyone. Remember, "an ounce of prevention is worth a pound of cure;" it is easier to stop something from happening in the first place than to repair the damage after it has happened. I look forward to seeing more of you at the shows.

Yet, there are members that do not abide by the rules. Can you imagine a member with a full sized tractor pulling two garden tractors with tow straps and two kids riding on the tractors? If there had been an accident, it affects all of us. I've seen this. It's good practice to have a safety meeting prior to an event as a reminder of the rules and to follow those rules throughout the show.

You can drop in on other EDGETA shows and use your membership card to show that you are a member of the national organization. This is very handy--\$8.00 per year goes to the Insurance-that is 66 cents per month. MARK THAT THE BARGAIN OF THE YEAR! I do believe a lot of presidents do not read the national newsletter or mail from the National EDGETA Organization. If you are a president and get the National Newsletter, you should take it to the next meeting and read the total letter aloud to the members. Then ask for questions. It is very important that we get the branches hooked back up to the national organization. If your branch is talking about dropping out, go to the EDGTA.com web site, click on the gold tab on the left labeled "Administration" and send an email to every director and director-at-large with any problems you might have.

Please do not drop out. If you wait till end of year and do not sign up for another year, the damage is already done. We want to work with you to try to prevent this from happening. Every member and every Branch is very important. I want to thank the members who called after the last newsletter. I want to thank you for being concerned.
