From George Christmas, President and SE Regional Director

I hope everyone is having a good spring so far. It is officially spring now. The pollen is in the air, and my hay fever is running wild. The National show is just a month away. I hope you have made your plans to attend the show. It is hosted by branch 114. The show will take place at Tehama County Fairgrounds in Red Bluff, CA. I am looking forward to it myself. Hope to see many of you there.

Everyone should have their memberships and dues paid by now. It is very important when you report your members that you include their name, address and phone number. These are important pieces of information. Please note the information needed on the BRANCH MEMBERS FORM. It is also required for the insurance coverage to be in effect for each member. It is also required that each branch complete the BRANCH DIRECTORS UPDATE FORM. This form serves to help us identify who can be contacted at the branch. It verifies the officers for the D & O insurance. The form is set currently that if there is not a change for a specific position you can fill it in with the word "same" submit it, and the form will let the secretary know the correct contacts for your branch.

This section is very important. It needs to be very clear. Each branch is responsible for keeping copies of all membership lists sent to the national secretary. When the branch sends in a membership list, there are several things that need to happen. First, the member list must be complete with member's name, address and phone number. The list will not be accepted if they are not complete. There should also be a check with the correct amount of dues to coincide with the number of members on the list. An example is if you send a list of 30 members along with that completed list there is to be a check for \$510. That is \$17 per member. The secretary will not accept lists without complete information or checks without a list of members. If any of the information is in correct it will be returned to the branch to be corrected. This may interfere with insurance coverage, so make sure you

have everything correct before you send it. Remember, if we don't have a name, complete address and correct amount of dues the individual is not covered. Member lists and dues for the year should have been received by the secretary/treasurer on or before March 15. It would be a good idea for the person sending the check to verify the number of members reported on the roster. It would also be a good idea to send a printed copy along with the check. Please contact any of the directors if you have questions.

The board was able to find new insurance coverage this year. The new policy will cover member-to-member accidents. As you are aware, the old policy did not offer this coverage. The board has shopped for several years to find this coverage; unfortunately, it was never at a price that was affordable until now. It did require a slight increase in the premium. There was also an increase in the deductible. The board decided the deductible members would be responsible for in the event of an accident would remain at \$1000. It is always our hope that the insurance will not be used. Hopefully, the new coverage will give a little more peace of mind. If you have any questions, please contact your regional director or any of the board of directors.

It is important that someone from your branch monitor the website for updated information. We routinely post updates on the website to quickly pass along information to our members. Usually, important reminders or announcements will be placed on a banner at the top of the home page so it will be noticed. Other updates maybe in the forms or in the frequently asked question section. The form section has links to all the current forms needed for communication to the national administration. Often, questions come up from branches or members that are very good questions, and in order to help other members, we post that question and the answer in the FAQ section. Again, this is to help any and all members get a clear understanding on a particular topic.

I would like to welcome David Millsap to the Board of Directors as the new Northeast Region

Director. David is from Virginia. He brings a lot of knowledge of antique iron. We are glad to have him aboard. We are still looking for someone to fill the Southeast Region Director position for the upcoming term. If you or someone you know is interested, please contact the Board of Directors.

Please share this information with all members. The Board of Directors are members of the association. We are elected by a vote of the membership. Each director serves a term of 3 years. The directors come from the region they live in, with the exception of the director-at-large who may live in any of the regions. This is a membership run association. Please look for the information in the newsletters and on the web site to see when the director position in your respective regions will be up for re-election. I encourage all those interested to get involved. It takes all of us to keep our association strong.

I always try to end with a thought on safety. It is extremely important we do all we can to make this hobby safe for the spectators, but also for ourselves. We need to make sure we are following the guidelines set forth and posted on the web site for everyone to view at any time. We must practice safe handling of equipment so we don't injure ourselves. I recently was loading a tractor for a show and realized if the weather conditions changed, loading that tractor would not be safe. I had to change the way I loaded it plus decide on another tractor to take with it since the load would be stacked differently. This is only one example of thinking ahead to what may happen "if." We must constantly do that. That type thinking will keep us ahead of the game and safer. Please remember safety is everyone's business. If you witness another member in an unsafe practice, behavior or display, you need to bring that to the branch safety officer's attention so it can be corrected. I recently went to a show which was not an EDGE&TA show. Some of the things I saw really scared me. I wondered how anyone could think some of the stuff going on there would have been safe. There were multiple people riding on the same tractor. There were moving displays not roped off. There was a large crowd and a lot of unnecessary movement on the show grounds. It only takes one incident to change to course of a show. Please make sure you are following the guidelines to make your show or display, wherever you are, safe for you and the spectators. Our insurance covers us against claims by spectators only. We do not have coverage between members or participants. I

encourage you to contact your regional director if you have questions about coverage.

Insurance Update, March 2019, By Dick Tombrink, NW Regional Director

I thought last winter was a cold snowy year, but this one wasn't any better, even colder. It started out pretty nice until we got to February. Then it turned cold and stayed there. We had daytime temperatures in the 10's and 20's and nighttime temperatures below zero for the whole month. Our coldest was -35 below, with many nights in the -20's. It turned out to be our second coldest February on record.

As you know EDGETA will change to a different insurance carrier on April 15th. This new carrier will provide us with participant liability coverage which we did not have before. This means that we are now covered for a liability accident or incident between fellow members, and also between a branch member and someone who is not a branch member when we are participating in community parades. This is in addition to the General Liability and Excess Liability policy coverage that now have.

We will continue to have Directors and Officer's insurance liability coverage as we have in the past. That will not change. However, at the recommendation of our insurance agent, we will not show it on our website, but we still have it. The reason it is being deleted from our website is that we were recently involved in a lawsuit that involved our D&O insurance carrier. We believe that the lawyers read on our website that we had the D&O coverage and that prompted them to pursue a lawsuit against EDGETA which they knew the insurance would pay for.

One of the important things that each branch needs to be aware of and do is to yearly update the list of your branch's directors and officers on the website. If a D&O related suit is filed against your branch and your list is not up to date, and if the person the suit is filed against is not on the list, they have no coverage. Updating your D&O list is easy to do. The list is online on our website for each branch. Check your branch number on our EDGETA branch location website and be sure it shows that the list is updated for 2019. If not, please update it at your earliest convenience.

As part of the new participant liability coverage, we will update our Insurance FAQ's on the EDGETA website to reflect the change. These will be posted on the EDGETA website about April 15th, when the new policy takes effect. Please review these FAQ updates and become familiar with them.

I am sure most of you have sent in your dues for this year to Carrie Jo. If not please collect them from your members and send them in. Remember dues this year are \$17 per member, a \$5 increase from last year to pay for the Participant Liability coverage.


1500 per year using a 1960 John Deere 730 Diesel and a 1959 CASE 311B. Who says that you need new cab air-conditioned comfort to get by?

Attracting the Youth:

As National and Regional Coordinator, one the most common comments I get when talking to Branch Presidents and Vice-presidents is "the young aren't interested." This may be true, but if each of us don't take time to encourage and help a young person, then there is no hope.

So how can it be done?

If you are like me, each of us owns at least 1 or 2 common single-cylinder engines. The same can be said about common tractors. As we upgrade our collections, often the common engines and/ or tractors may end up in the "back forty" or on "rotten row." If you decide it's time to haul those relics to a swap meet, what happens? You spend a day loading and hauling, and then wait until some jockey

tries to beat you down so they can buy it "just for the mag" and for a few \$ it's gone. Why bother!

Here's where you can hook a young individual who hangs around looking at that engine or tractor, No, you can't just "give" it to him or her because if you do, it'll end up in a corner and nothing gets done. You have THEM write a CONTRACT. You can specify the terms: i.e. #1. I need to get the engine or tractor running by a specific date; #2. I must take this treasure (tractor or engine or ?)to at least 1 show per year for 1 or 2 years.

I believe it's a responsibility of each of us, no matter the level of your experience, to help and encourage the young. This is one method I have found that works. The individuals I've helped have stepped up their own collection. They may step away for a while when advanced schooling and/or marriage comes long, but they will come back.

Hope all of you had a Happy New Year--by now, 2019 is well under way. Many have already attended shows this calendar year. A very big "Thank You" to the branches that have sent their memberships on time. It is a very big responsibility for you to keep and maintain the membership for your branches. However, there are several branches who still need to send their dues. The new membership year begins April 15, 2019; unless memberships are renewed prior to then, members will not have membership coverage until those dues are paid.

One housekeeping chore that we need to take care of is the updating of new officers and directors. This must be done at the beginning of each year, even if you maintain the same officers. Go to the EDGETA.org website, scroll down to the yellow tab "Branch Officers Update Form" and enter those. Do the same for Directors. If the information is the same as last year, just enter "same" in the blank for the name of the person in that office. If their address, phone or email changes, please make that change. Any and all changes must be entered. Please be sure that someone in your branch takes care of updating officers on the website each year and each time something changes. I take all officer information from what has been submitted to the website.

not from a list included in the membership information with the check.

It's been mentioned already that the new year for EDGETA begins April 15, so please get your membership information turned in so that you will have continuous coverage of the advantages that EDGETA membership offers. A new "Branch Members Form" was posted on the website 4 years ago that allows 24 members and information per page. It is at the bottom of the home page and is labeled "Branch Members Form." Some of you are still using the previous form that allows only 5 members per page. It would be very helpful if you could switch to the new form.

To clarify membership guidelines, below I'm inserting the Section of the By Laws that addresses membership. Only individuals (<u>not companies or organizations</u>) are eligible for membership as stated in our By Laws.

ARTICLE III - MEMBERSHIP Section 1. Members:

- a. Eligibility for membership is unrestricted.
- b. The rights, privileges, and interests of each member shall be equal.
- c. A member in good standing is one whose dues are current, is listed on a Branch Membership Roster, and has a valid membership card showing their branch number.
- d. The period of membership shall be for one year, beginning on April 15, with the exception being a member joining a branch after April 15. Such member shall be a member until the end of that membership period.
- e. Membership shall be for individuals only. Company names or family group names are not acceptable.
- f. Members only have to be reported to the Association by one (1) branch.
- g. All members shall participate in the Association Liability Insurance Program.

Spring is here and the National Annual Meeting is April 26-28 in Red Bluff, CA hosted by Branch 114. They have been working hard to have a good show and to make all those who are traveling to California feel welcome and make the experience memorable. I am excited about going to California and meeting people I've communicated with regarding the details of the meeting as well as other guests.

Hope to see some of you in California.
