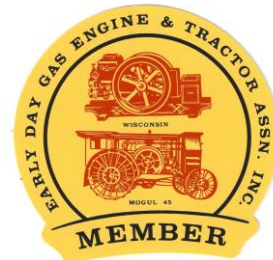
ideas or need help just give your Director or me a call. I have gotten great input from branches across the country and enjoyed talking with all the different members.

I grew up in a very small town in Northeast Texas. My Dad attempted to make a living farming after returning from the war. It didn't take long for him to realize he couldn't make it with 40 acres and a Farmall Cub.

As I grew up, I never realized we were poor, but I guess we were. My parents always seemed to make sure I had what I needed. That all changed in 1964 when my Dad lost his eye in an accident while using a hammer and chisel. He was off work for over a year so my mother and I both had to go to work. My first job was raking hay on a B Farmall for 35 cents an hour. I was 13 years old at that time.

I don't have many regrets in my life, but I do regret not taking advantage of the knowledge my Dad had to offer when it involved working on what we now call antique cars and tractors. He was truly a great mechanic.

My Dad worked as part of a pit crew for a gentleman who raced at the Devil's Bowl every weekend. We traveled every weekend to different race tracks, but the Devil's Bowl was the one I remember the most.

I remember times when I would beg to go to work with him and help. He would assign me the task of cleaning tools or scraping gaskets. I didn't realize at that time that this was a very important part of the learning process, and I was not ready to tune an engine or replace a clutch on a tractor.

After the garage closed, my Dad would go to the fields to work on farmer's tractors or work on them under the trees in the backyard. (Shade tree mechanic at its best.) He would go to the widow women's houses and work on their cars and even replaced parts without charging them a penny.

Today, when I am working on one of these old tractors and I have a problem, I find myself thinking, "If my Dad was here, he could figure this out." He was truly a great man and mechanic, so it is with much honor and respect I dedicate this article to John Paul Roderick—my Dad!

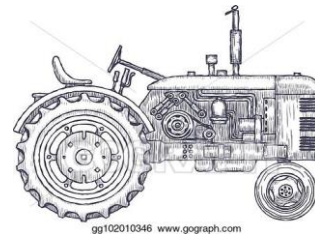

On another note, "thank you" for doing a good job submitting your membership and dues for the year. Most of you are aware that the insurance auditor comes to my house randomly to examine the individual Branch# files to verify how members were submitted with payment and how the proof of payment was kept. He is also interested in the process I use to record membership and how I determine the total maximum number of members during our year running from April 15 one year to April 15 of the following year. He pulls random branch files to check the record of membership and the number for which we've paid as of that date. This may help explain the reason for my insisting that your record of membership submitted match the amount of the check included. A copy of that check is stapled to the list submitted for examination purposes. That's why we request a "clean list" from you. All of our guidelines are included in the By-Laws which are posted on the EDGETA website.
