There is a learning program, a test, then the safety officer signs off on them indicating that they have filled all the requirements. He mails the application to Howard, and Howard then fills out a certificate and mails it back to them. It is a plastic covered card that they can clip on the collar so your can tell one of them when you see them . It is a bright orange in color. Howard said there had been some discussion on lowering the age limit, some of the board members have kicked it around, but feel that 12 years of age is as low as they want to go.
