4. The lien of real estate taxes or assessments imposed on the title by a governmental authority that are not shown as existing liens in the records of any taxing authority that levies taxes or assessments on real property or in the public records.

5. Oil, gas, coal and other mineral interests together with the rights appurtenant thereto whether created by deed, lease, grant, reservation, severance, sufferance or exception.
6. Subject to those certain recorded and unrecorded rights-of-way for the public or private roads and for railroads, and easement public utility lines.

Parcel 1 Description:

BEING that certain parcel or boundary of land located along Mill Creek/Huggietown Road, north of Terry, West Virginia, in the Plateau District of Fayette County, West Virginia, designated on the Assessor's Tax Maps as Parcel 55-17, known as the remainder of Coit 3 Surface Tract, and which property is more particularly described from records as follows:

BEGINNING at a limestone monument on a south hillside on the Fayette/Raleigh County line, a common corner to the Dunedin Fee Tract and the Coit 3 Surface Tract shown on "Map Showing Fee and Surface Lands Located in Fayette & Raleigh Counties, WV, Owned by The Erskine Company, Staunton, Virginia," by Thomas W. Howard of Fayette Engineering Company, dated February 16, 1987 and on a line of property now or formerly owned by Arrow WV, LLC,; thence with Arrow WV, LLC N65° 40' 08"E 551.05 feet to a set stone on top of a ridge; thence continuing N65° 40' 08"E 3999.42 feet to a limestone monument in a hollow (with 5" cucumber, 24" black oak, and 5" poplar pointers); thence leaving Arrow WV, LLC S24° 17' 39"E 2223.52 feet to a limestone monument on a southeast hillside (4" poplar, 20" poplar, and 16" Spanish oak pointers); thence N85° 42' 50"E 650.70 feet to a point, a common corner with USA Tract 132-14, shown on a plat titled, "New River Gorge National River, Fayette, Raleigh, and Summers Counties, West Virginia, Boundary Line Survey Made For The National Park Service of The Department of the Interior," by G. A. Tice, Inc., dated January, 1993, which is the basis of bearing of this description; thence with USA Tract 132-14 S8° 03' 04"E 483.66 feet to a point on the county line near Salt Lick Branch, a common corner with another USA tract; thence leaving USA Tract 132-14 and with the other USA tract N84° 14' 51"W 3846.91 feet to a limestone monument, a common corner to the Dunedin Fee Tract; thence leaving the USA tract and with the Dunedin Fee Tract now of formerly owned by Stretcher Neck Properties, LLC N84° 14' 51"W 1960.05 feet to the point of beginning; and containing 142.03 acres, more or less, after excluding the 30-foot wide right-of-way for West Virginia Route 28 (Mill Creek/Huggietown Road).
