Terms of Use

1. Introduction

("we," "our," "us") in collaboration with VYCTO (Vycto Tech LTD). By accessing or using this fan zone, you agree to these Terms & Conditions ("T&C"). If you do not agree, please refrain from using the platform.

2. Definitions

- "Platform" refers to the fan zone accessible at <u>ael.vyctorewards.com</u>.
- "User" refers to anyone accessing or participating in the platform.

3. Amendments

We reserve the right to update these T&C at any time. Updated versions will take effect immediately upon publication on the platform.

1. Eligibility and Entry Restrictions

- 1.1 **Competition Duration:** The duration of each competition will be specified by the countdown displayed on the 'Home' page. The countdown will conclude at the start of the AEL fixture to ensure fairness for all participants.
- 1.2 **Identifc Verification:** Proof of identity, including 'Full Name' and 'Age,' may be required from prize winners to confirm eligibility and verify they are not bots, fake accounts, or repeat entries. Winners may also be required to sign an acceptance statement upon receiving their prize.
- 1.3 **Proof of identity:** If a winner is a minor under the age of 18, they may accept the prize provided they have the consent of a parent or guardian.
- 1.3 **Prizes:** Details of prizes are indicated in the "Rewards" section for each specific competition. Administrators reserve the right to substitute prizes in case of logistical or administrative issues.
- 1.4 **Entry Limitations**: Each user is limited to one entry per competition. Multiple entries will result in disqualification.
- 1.5 **Social Media Participation:** Entrants participating via social media must have an active, genuine account. Promotions on social media are not sponsored, endorsed, or administered by any social network. Users provide their information to us in line with our Privacy Policy.

AEL may offer monthly prizes to top performers on the "Monthly" or "Season" Leaderboard.
- 2.2 **Prize Options:** Winners may opt for a lower-ranked prize at their discretion. For instance, if the first-place winner selects the second-place prize, the second-place winner will then receive the first-place prize.
- 2.3 **Notification and Claiming:** Reasonable efforts will be made to contact winners within ten (10) calendar days. If a winner fails to respond, meet eligibility requirements, or provides incorrect account information, the prize may be awarded to the next eligible participant.

- 4.1 **User-Created Entries:** Users warrant that their competition entries are original and do not infringe any third-party rights. By submitting an entry, users grant AEL and Vycto an exclusive, worldwide, royalty-free, perpetual, and irrevocable license to use the entry.
- 4.2 **Leaderboard Visibility:** Entries may be publicly displayed on leaderboards during the competition.

5. Data Privacy

- 5.1 **Data Collection:** Personal data collected for competitions will be processed in compliance with the General Data Protection Regulation (GDPR) (EU) 2016/679. Data will be retained exclusively for competition purposes and not shared without prior consent.
