or parcel of land and premises, hereinafter particularly described, situate, lying and Township being in the ofHopewell in the County Mercer and State of New Jersey, butted and bounded as follows:

BEGINNING at the River Delaware, corner to Bernard Taylor, thence with Taylor's line north fifty-two degrees and thirty minutes east, twenty three chains and eighty links to a stone, corner to said Taylor; thence, with his line, north thirty-nine degrees and thirty minutes east twenty-one chains and four links to a stone; thence, North forty-three degrees east, twenty seven chains and twenty nine links to the middle of a small run of water in James' Burrough's line, the several courses thereof to the River Delaware, thence down the said river seventeen chains and twenty links to the beginning - containing within the said bounds aforesaid onehundred and twenty-three acres of land, more or less.

EXCEPTING and reserving out of this present conveyance, a lot of land sold to Elias Keller as by reference to deed bearing Anno Domini 1878, also so much of said premises as were sold to the Delaware and Raritan Canal Company for the use of said feeder, and all the right and privilege of fishing on said premises as conveyed by deed to the Taylorville Bridge Co., by Joseph B. Tomlinson, deceased, late of the place aforesaid.

ALSO the free full and unobstructed right of way over the tract of land mentioned and described in a certain deed made by Bernard Taylor to James B. Tomlinson, bearing date the fourth day of September in the year eighteen hundred and forty-three, and recorded in the Clerk's office of the County of Mercer in book F of deeds, page 146 in as full and ample a manner as in said deed granted, that is to say, over all that tract of land of the said Bernard Taylor situate in the Township of Hopewell, in the County of Mercer aforesaid, lying and being within the distance of twelve feet on each side of a center line beginning on each side of a center line beginning at a lower gate post now standing in the line fence between said James B. Tomlinson's and said Bernard Taylor, fifty-three feet in an easterly

ALSO, EXCEPTING and reserving out of this present conveyance, all those two certain tracts of land at Washington's Crossing, New Jersey, bounded and described as follows according to the magnetic bearing recorded in deed by Alstyn D. Blackwell to the State of New Jersey, dated January 4, 1912, said land being situate in the township of Hopewell, in the county of Mercer and State of New Jersey, more particularly described as follows:

First tract: Beginning at a stone in the southeast line of lands of Isidor P. Strittmatter, said stone being the most northerly corner of lands now or formerly of Austin C.
