WOLFE, single, of the City of New York, County of New York and State of New York, party of the first part, and THE STATE OF NEW JERSEY, DEPARTMENT OF CONSERVATION AND ECONOMIC DEVELOPMENT, party of the second part.

WITNESSETH, that the said party of the first part, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, lawful money of the United States of America, to him in hand well and truly paid by the said party of the second part, at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, and the said party of the first part being therewith fully satisfied, contented and paid, has given, granted, bargained, sold, aliened, released, enfeoffed, conveyed and confirmed, and by these presents does give, grant, bargain, sell, alien, release, enfeoff, convey and confirm unto the said party of the second part, and to its successors and assigns, forever,

ALL that certain tract or parcel of land and premises, hereinafter particularly described, situate, lying and being in the Township of Hopewell, in the County of Mercer and State of New Jersey, bounded and described as follows, to wit:

BEGINNING at a corner in the middle of the brook corner to land of Alexander H. Drake; thence along the line of land belonging to the said Alexander Drake North 24 3/4 degrees West 17 chains and 50 links to a stone; thence North 60 1/2 degrees East 8 chains and 38 links to a stone; thence North 30 degrees West 7 chains and 82 links to a stone corner to land of Alexander H. EXCEPTION NO. 6:-

BEGINNING at a point in the Easterly line of the River Road said point being distant 390.02 feet measured Northerly along the Easterly line of the River Road from the intersection of said line with the center line of Steel's Run, and running; thence (1) North 21 degrees 24 minutes West along the Easterly line of the River Road, 50 feet to a point; thence (2) North 68 degrees 36 minutes East 200 feet to a point of curvature of a curve; thence (3) by a 10 degree curve to the right, having a radius of 573.69 feet, 186.67 feet to the point of tangency of said curve; thence (4) South 00 degrees 18 minutes East along the west bank of a branch of Steel's Run, 21.88 feet more or less to a point; thence (5) South 68 degrees 36 minutes West, 371.8 feet to the point and place of BEGINNING.

Wolfe does for himself, his heirs, executors and administrators covenant and agree to and with the said party of the second part, its successors and assigns, that he, the said Alam L. Wolfe, is the true lawful and right owner of all and singular the above described land and premises, and of every part and parcel thereof, with the appurtenances thereunto belonging; and that the said land and premises, or any part thereof, at the time of the sealing and delivery of these presents, are not encumbered by any mortgage, judgment, or limitation, or by any encumbrance whatsoever, by which the title of the said party of the second part, hereby made or intended to be made, for the above described land and premises, can or may be changed, charged, altered or defeated in any way whatsoever, except as aforesaid

AND ALSO that the said party of the first part now has good right, full power and lawful authority, to grant,

bargain, sell and convey the said land and premises in manner aforesaid.


