Mrs. Dilts was a very faithful worker in the various organizations of the First Presbyterian Church of Lambertville, New Jersey. Possessing a very beautiful mezzo-soprano voice, she sang in the church choir for over thirty years. Her father was brought up in the mercantile business and became the junior partner of the firm of Holcombe & Son. He gave up that business and studied law: after he was admitted to the bar he practiced law in Lambertville until his death, and during this period was mayor. Previous to the Civil War, he was commissioned by Governor Newell as Judge Advocate of the Hunterdon Brigade, and held that position after the war broke out, when as a member of that board, he assisted in enrolling the militia of the county. During the war he was commissioned by Adjutant Stockton to raise a company of volunteers; under an act of the Legislature, passed in 1876, he was appointed by Governor Bedle as one of his aides, ranking as colonel. Her mother was noted for her deeds of charity and was very prominent in church work.

Mr. and Mrs. Dilts are the parents of one son, Alexander Robert, who was born March 19, 1895, and who, during the World War, served in the Aviation Corps of the United States Navy, receiving his commission as ensign just before the Armistice was signed. Alexander Robert Dilts married Helen Iza Bingham, of Boston, Massachusetts. May 31, 1924, and they are the parents of one son. Alexander R., Jr., born December 19, Miss Bingham's parents were Charles Sumner Bingham (deceased) and Mary Ann Roberson. She is a descendant of Oliver Holden, who wrote "All Hail The Power of Jesus' Name," and members of her family were all musically gifted. She possesses a wonderful soprano voice. Her mother's father was Dr. Walter Scott Roberson, a famous physician in Northern New York State, in which State her family originated. Mr. and Mrs. Alexander R. Dilts now reside in Manchester, New Hampshire, where Mr. Dilts is connected with the Firestone Tire and Rubber Company.

THOMAS JOHN WALKER-For more than fifteen years Thomas John Walker has been the proprietor of a grocery business in Lambertville, New Jersey, and he is now the proprietor of
